#### **R v Samuel James [2021]**

Represented the defendant who was accused of humiliating and degrading rapes of his former girlfriend. Partial acquittal.

---

#### **R v Trevor Monk [2021]**

Successfully prosecution of man charged with rape

---

#### **R v Burrows and Prewitt [2021]**

Prosecuted a couple who systematically raped and abused 2 children. Both received an extended sentence comprising of 22 years custody and an 8 year licence. This was a case of huge sensitivity.

### **Historic Sexual Offences**

---

Miss Eley has been prosecuting and defending in historic sexual cases for many years, she is well known for her meticulous preparation and attention to detail.

#### **Notable Historic Sexual Offences cases**

#### **R v Shane Moore [2021]**

Prosecuted non recent sexual abuse. The defendant accused of historic abuse of his niece, partial convictions secured.

#### **R v Cantwell [2021]**

Secured conviction of man charged with historic sexual abuse

#### **R v Peter Moxon [2019]**

represented a man charged with historic sexual offences and secured acquittal

### [R v Hackman \[2017\]](#)

secured acquittal of man charged with rape

## Gangs & Organised Crime Groups

---

In recent times Miss Eley has experience prosecuting these types of offences, usually in cases where there is a back ground involving drug supply.

### Notable Gangs & Organised Crime Groups cases

Prosecuted serious drugs conspiracy involving millions of pounds worth of cocaine.

Was led successfully in prosecuting these individuals in a county lines drug operation, they received substantial prison sentences.
